Public Notice of Rate Increase from Montgomery County Regional Sewer District (MCRSD)

Dear Customer,

This notice is to inform you that the Board of Trustees of the Montgomery County Regional Sewer District (the "district") has adopted a new schedule of rates for sanitary sewage collection and treatment service provided to your property. Rates will increase by 50%. The monthly bill for unmetered single equivalent dwelling units will be \$77.40. A copy of the new schedule of rates can be found attached to this letter or at https://montgomeryrsd.com/resources for your reference in compliance with Ind. Code §13-26-11-13 and Ind. Code §13-26-11-15.

The district is required by state law to cover its operating expenses and operate without exceeding its cash on hand. Due to increases in the district's costs to maintain the collection system and stay in compliance with the requirements of the Indiana Department of Environmental Management, this rate increase is needed for the district to remain solvent and provide sanitary sewer service to Montgomery County.

The district's operating costs have increased continually over the past 11 years with an increase of 20.4% between 2021 and 2022 alone, mostly from utility expenses and equipment replacement needs. We expect operations costs to continue to rise by about 5% per year for the foreseeable future. Further, inflation measured by the Consumer Price Index has increased 40.44% since the district's formation with no adjustment to compensate for that inflation ever implemented. This is the first rate increase in the 12-year history of the district.

You have rights under Indiana Code Section 13-26-11-15 to appeal this increase by filing a written petition to the district. A petition must set forth the grounds for the objections and 1) contain the name and address of each petitioner; 2) be filed at 1580 Constitution Row, Suite E, Crawfordsville within 30 days of the date of this notice, by July 21 2023.
