

**MONTGOMERY COUNTY REGIONAL SEWER AND WATER DISTRICT**

**ORDINANCE NO. 2024-01**

**An Ordinance Amending and Establishing a Schedule of Rates and Charges to be Collected by the Montgomery County Regional Water and Sewer District from the Owners of Property Served by the Sewage Works of said District and Other Matters Connected Therewith.**

WHEREAS, by its Ordinance No. 2011-1 (the "Rate Ordinance"), subsequently amended by Ordinances 2013-01, 2017-01, and 2023-01, the Montgomery County Regional Water and Sewer District (the "District") adopted a schedule of rates and charges to be collected by the District from the owners of property served by the sewage works of the District; and

WHEREAS, the District finds it necessary to amend the Rate Ordinance to ensure expenses do not exceed revenues and the district operates in compliance with Ind. Code §§ 13-26-11-8 and 9.

**BE IT THEREFORE ORDAINED AS FOLLOWS:**

Section 1. The "Schedule of Rates and Charges" set forth in the Rate Ordinance (Ordinance No. 2011-1 as amended) is hereby amended to read as set forth on Exhibit A, attached to and made part of this Ordinance by reference.

Section 2. All rates, commercial or residential, negotiated between users and the district are hereby increased by 27%.

**IT IS FURTHER ORDAINED AS FOLLOWS:**

**Prior Ordinances Repealed.** All ordinances or parts of ordinances in conflict herewith are hereby repealed. All other provisions of Ordinances 2011-01, 2013-01

and 2017-01, and 2023-01 not amended by this Ordinance shall remain in full force and effect.

**Separability of Provisions.** The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.


**Effective Date.** This Ordinance shall be effective December 1, 2024, unless otherwise provided by law.


